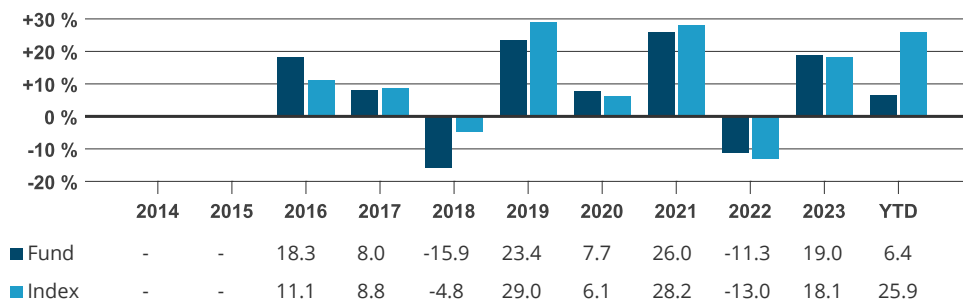

Monthly commentary, November 2024

The US election results had a significant impact on market performance in November, with expectations of tax cuts, fiscal policy expansion, and nationalist trade policies driving US equity markets to new highs.



Outside the US, the reaction was more cautious, with uncertainties over trade policies creating apprehension. Overall, the market's optimistic response was somewhat tempered by concerns over potential inflation and the Federal Reserve's future actions. Interestingly, signs of a rotation into small and mid-cap stocks have emerged and firmly materialised in US equity markets. We believe there is a high likelihood that the "great rotation" will continue into global small and mid-caps outside the US, which currently trade at exceptional discounts compared to history.

Our strongest positive contributor during the month was US regional bank First Horizon, which saw a 16% rally following election results and later continued to re-rate towards our target price. We therefore reduced the position. Canadian listed packaging producer Cascades also performed well as investors are discovering the investment case and beginning to sense the earnings potential of reduced cap-ex levels combined with easing recycled fibre costs and more favourable market conditions.

On the weaker side, Mexican transportation and logistics company Traxion faces near-term sentiment challenges from tariff concerns, macroeconomic pressures, and a weaker currency. At these levels, we believe that the shares of Traxion discount an exceptionally depressed outlook which offer an attractive risk/reward in the medium term.

In November, we entered a position in the French car-leasing company Ayvens which trades at an unwarranted discount to our estimate to fair value, and is currently also plagued by the French political discount.
